# Latest Paid Leave Updates Released





**Attention Operators:** Next year's launch date for Minnesota's upcoming Paid Leave program is quickly approaching.

**Stay informed:** Here's what hospitality owners and operators need to know from the latest update from MN DEED:

- **Program launch date:** Minnesota will implement its Paid Leave program on January 1, 2026. With it's launch comes significant changes for your employees.
- Employee leave entitlements: Be aware that eligible employees can take up to 12 weeks of family leave or 12 weeks of medical leave per benefit year. In combined cases, an individual could take up to a maximum of 20 weeks.
- **Intermittent leave:** Understand that leave for qualifying conditions lasting at least seven days can be taken **intermittently**, offering flexibility for employees managing ongoing health needs.
- **Health insurance premiums:** Note that employees on leave will still be responsible for paying their portion of health insurance premiums.
- **Stay informed:** The Paid Leave program is actively engaging with stakeholders. Keep an eye out for future newsletters specifically for employers.
