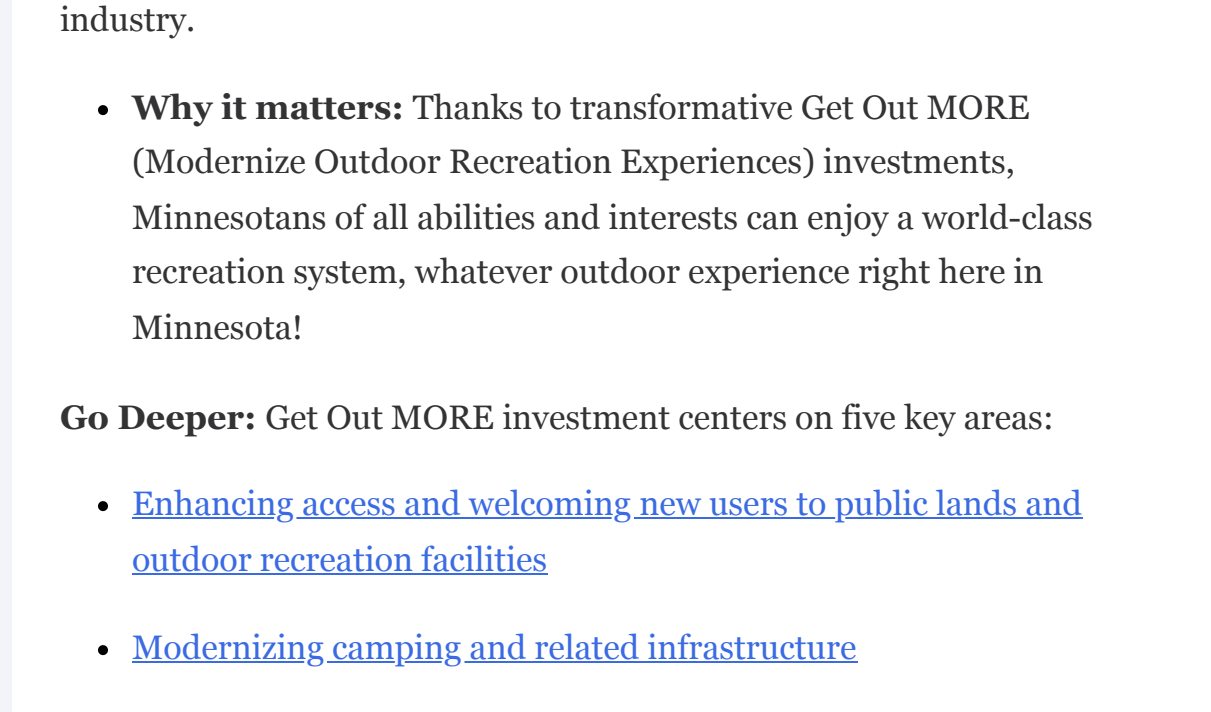

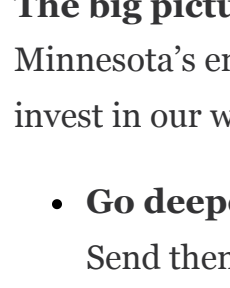
June is Great Outdoors Month: Outdoor recreation is central to Minnesota's identity, fundamental to our economy, and essential for our industry.

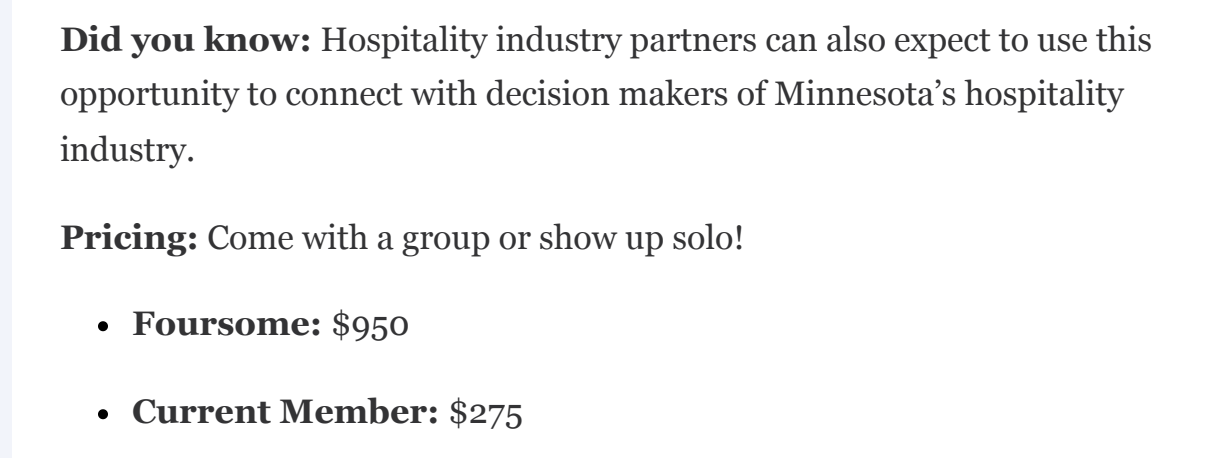

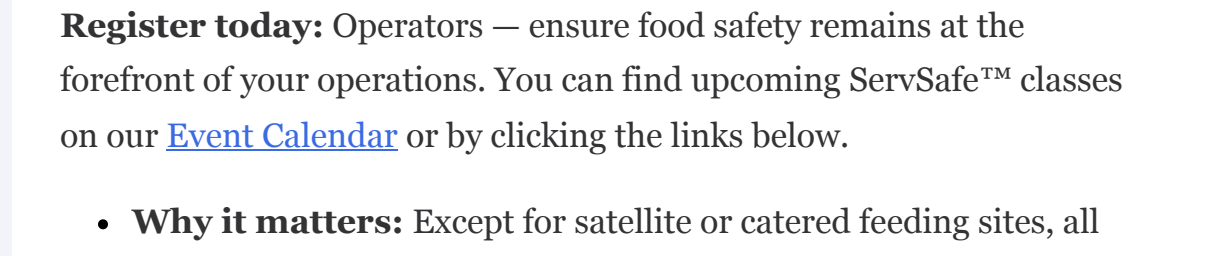

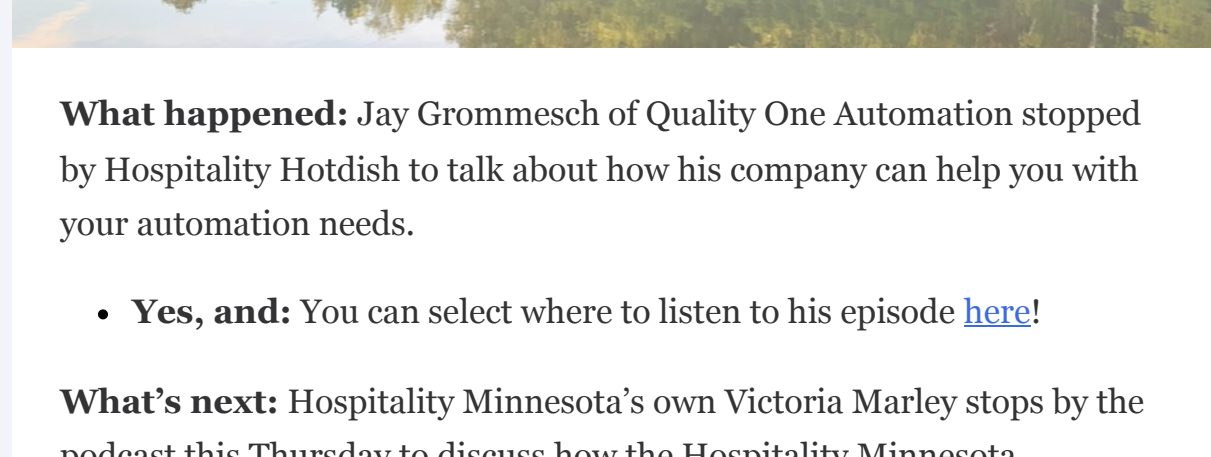

Jay Grommesch of Quality One Automation Stops by Hospitality Hotdish

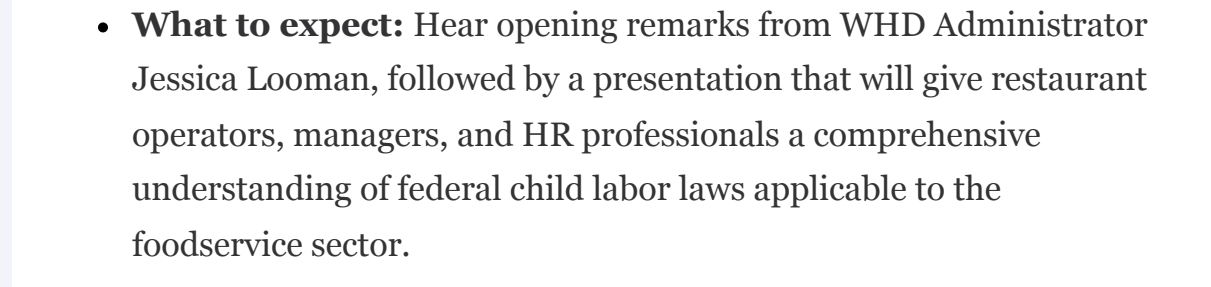


What happened: Jay Grommesch of Quality One Automation stopped by Hospitality Hotdish to talk about how his company can help you with your automation needs.

NRA to Host Child Labor Law Compliance Webinar June 18



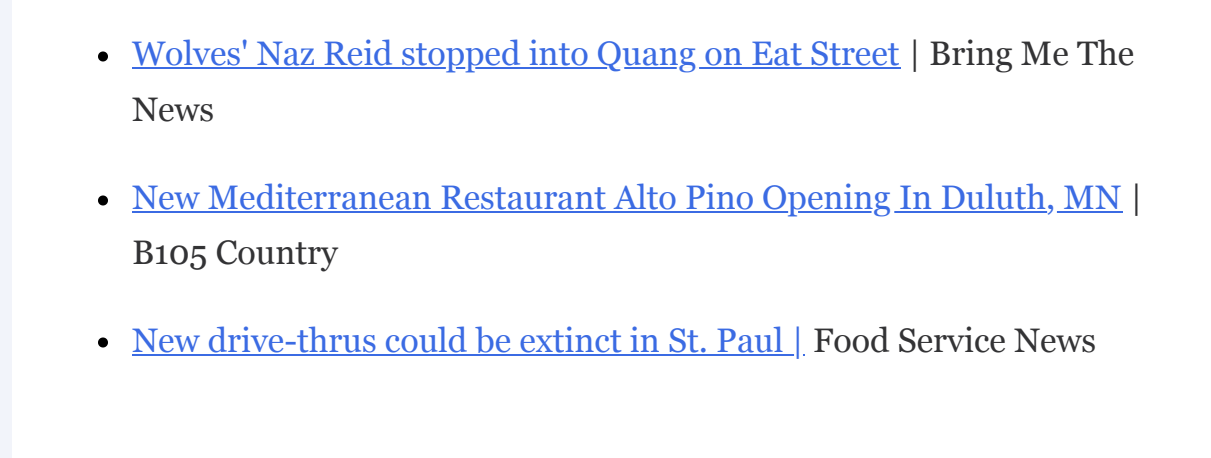
