**Some Background**: AHLA and 12 business groups are suing the U.S. Department of Labor in federal court to stop the department's <u>new</u> overtime rule, which will increase certain employee-labor costs for hotel

• DOL's rule violates a 2016 court order that said it is illegal to base federal overtime pay determinations on salary levels alone Federal overtime pay determinations must take into account employee duties Automatic overtime threshold increases are unlawful




