Office of Cannabis Management announces next steps for licensing process



What's happened: The Minnesota Office of Cannabis Management (OCM) has announced a new approach to launching the state's cannabis industry, including canceling the pre-approval lottery, <u>which will likely</u> <u>lead to delaying the start of retail sales</u>.

Here's the breakdown:

- **No More Preapproval Lottery:** The original preapproval process with its lottery system is ending.
- **Standard Licensing Cycle for All**: Both social equity and general applicants will participate in a new licensing cycle opening in early 2025.
- **Benefits for Preapproved Applicants**: The 648 applicants who qualified in the pre-approval process will automatically be considered in the new round.
- **Social Equity Focus**: Social equity applicants will have reserved lottery spots and dedicated support.
- **Timeline**: Applications open Feb. 18, 2025, with social equity verification starting Jan. 15, 2025.
